

JAMAICA TRIP CONTRACT (Revised 5/23)

The terms and conditions outlined herein cover trips operated by CREATIVE TRAVEL, INC., 837 Solarlight Dr., York, Pa. 17402 Creative Travel web site: www.creativetraveljamaica.com.

- 1. CANCELLATIONS & REFUNDS – Your right to a refund is limited. A nonrefundable deposit of 20% of the villa cost is required to book a villa in advance. This nonrefundable deposit can be transferred to others if they replace you in the villa and the replacement persons are approved by others in the villa. If you don't replace yourselves you will still owe your portion of the villa cost or pay the difference in price passed on to the others in the villa. If the entire villa cancels then a full refund less \$100.00 (Administration fee) is duly permitted 180 days prior to your trip. A full refund less \$200 (Administration fee) is permitted for cancellations between 119 and 179 days. No refunds within 120 days of the trips departure. .

Group air tickets may be available for groups of 10 or more. A nonrefundable deposit of \$100 per person is required to book group air. Once group airline tickets have been purchased with individual names, no matter what date, there will be no refunds unless you replace yourselves with another person approved by the group. If the cancellation causes the size of the group to fall below the minimum required (10) for group air fare, the cancellation penalty will be \$200. minimum or the maximum cost of the increase in airfare cost.

Failure to pay in full on designated due dates is subject for immediate cancellation and forfeit of any deposit. If Creative Travel cancels the trip, some deposits will be refunded in full. However, in some cases, deposits for certain villas and airfare are nonrefundable and some can be transferred to a future date.

- 2. SERVICE CHARGE -- A service charge of \$50 will be in effect:
A) On each person not paying final balance owed within ten days of due date,
B) On each returned check returned by the bank for any reason.
3. RESPONSIBILITY – Creative Travel is the principal and arranges with travel agencies, airlines, hotels, transfer companies, car rental companies, private villas, food stores and other independent firms to provide you with these services. However, Creative Travel does not own or operate any of the firms which provide goods and services for the trip; therefore, each passenger agrees not to hold Creative Travel, in the absence of its own negligence of any loss, injury, expense or damage which results directly or indirectly from any act or omission, whether negligent or otherwise. Creative Travel shall have no liability to the passenger for (1) the quality of services at, and the condition or cleanliness of, a hotel or housing facility or for any mechanical breakdowns, government actions, weather, acts of God, or other circumstances, beyond its control; (2) the failure to obtain required documentation, including passports in which case the participant will forfeit all refund; (3) overbooking or villa cancellations whereby substitutions will be made. (4) Loss due to theft, robbery or an individual's negligence in securing personal valuables.
4. BAGGAGE – Creative Travel will not be responsible for delay of, loss of, or damage to baggage and its contents. Without prompt notification upon arrival at your destination, the airlines may not accept liability for damage, delay or loss. You must notify the carrier immediately upon noticing damage, delay or loss. Most airlines now charge for luggage, it is your responsibility to pay these charges. You are required to keep with you and be responsible for all carry on luggage.
5. INSURANCE – Trip insurance is suggested. Optional trip cancellation, baggage, health and accident insurance are available through AAA travel and other travel or insurance companies.
6. MISCELLANEOUS – Passengers are subject to direct air carrier ticket terms. No warranties, representation, terms or conditions apply to any trip unless expressly stated in writing. Fuel surcharges, increased transportation taxes or air ticket increases may be passed on at any time. Group air is quoted out of BWI prior to final negotiations with the airline and Creative Travel has the right to increase the cost of the trip based on any increased price for air travel. All passengers must have a valid Passport that does not expire within 6 months of the last day of the trip. Creative Travel is not responsible for passenger failure to comply.
7. I have read and I accept the provisions of Creative Travel, Inc., Jamaica Trip Contract regarding cancellation, refunds, payment and the operator's responsibilities.

The 2024 Jamaica trip is a villa package only. Creative travel will assist client in arranging food, transfers, excursions, massages, hotel package and if necessary group airfare (10 persons minimum)/ Contact information and any discounted programs will be passed on. There is no guarantee that any vendor will honor previous prices.

It is suggested that the villa cost be divided equally by the number of rooms rented. Clients can choose to divide the villa rental by the number of persons or create their single bedroom rate. Everyone in the villa should stay for the same period however this is not mandatory but highly recommended.

Group air is out of BWI providing that there are 10 or more persons traveling.

Estimated cost for group air is approximately \$525 to \$600 for all group trips (7 nights, 10 nights and 2 weeks). These prices are estimates and not guaranteed. You must have a group leader to handle the air paperwork. You can request Creative Travel to handle the paperwork and collection and payment of group air.

Do you want Creative Travel to handle group air roughly \$525 to \$600 for all group trips. These prices are estimates and not guaranteed. The group air deposit is \$50 and nonrefundable. The main advantage to group air is that you only have to pay the \$50 nonrefundable deposit and there can be a name change 10 days in advance at no charge. Balance for airfare due November 1.

Airport hotel package. Normally free parking for at least 10 nights and could be longer. Normally \$130 and currently using Aloft hotel at BWI. You may elect and book another location.
